\$5,000 Added **Gollhofer Indoor Arena** **Spearfish, SD** **Sept. 23rd & Sept. 24th**

- 2 go-rounds and an average paid out equally. Total time of the 2 rounds will determine the Championship standing.
- The Roper Rally Futurity is open to horses that are 5 years old or younger. Horses must not have reached the age of six by the time of the futurity.
- To be eligible for the Roper Rally Futurity, the horse must never have competed in any barrel race, including AQHA shows, playdays, derbys, rodeos, etc. prior to Dec. 1, 2009. To do so means forfeit of any and all fees paid and elimination from the futurity. Horses may have competed anywhere after Dec. 1, 2009. Horses may have been entered in other events.
- Nominations & sustaining fees: Any sustaining payments postmarked after date due will owe an additional \$20 late fee.
 - \$90.00 to nominate July 1, 2010
 - \$90.00 to sustain Aug. 1, 2010
 - \$90.00 to sustain Sept. 1, 2010
 - \$270 total fees
- Late Futurity nominations will be accepted through check-in Sept. 23rd. The late nomination payments are as follows:
 - To nominate July 2 - July 31, 2010
 - \$135.00 (plus Aug. & Sept. payment)
 - To nominate Aug 1 - Aug 31, 2010
 - \$270.00 (plus Sept. payment)
 - To nominate Sept 1 - Sept. 14, 2010
 - \$405.00
 - To nominate Sept 15 - Sept. 23 Check-in
 - \$450.00 (Money order or cashiers check only after Sept. 14th)
- Amateur division: To qualify for the amateur division at the Roper Rally Futurity the rider can never have won \$1,000 in a barrel futurity prior to Dec. 1, 2009. Amateur status must be declared by Sept. 14, 2010. \$25.00 entry fee. 30% office charge. Entry fee will be jackpotted back in the 2 run average.
- Rider Changes: Rider changes may be made through the end of check in. A fee of \$50 will be assessed after Sept. 14, 2010. It is the owner's/rider's responsibility to be sure that Z Productions has the correct rider listed. Horses must be ridden by the same rider throughout the event, however if injury is sustained, an exception will be made. A Dr.'s release must be submitted for consideration.



- Substitutions are allowed only due to injury/death of the nominated horse. A veterinarian's affidavit of proof must accompany substitution paperwork along with a \$50.00 fee. Deadline for substitutions will be Sept. 14, 2010. Substituted horse must have the same owner as nominated horse.
- Horses nominated Sept. 15 through check-in Sept. 24 will run at the bottom of the draw in round 1 and the top of round 2. Reverse order from 1st go. These horses will not be posted in the program.
- Should a nominated horse be sold during the payment period, written authorization must be received from the original owner before the horse can continue to be paid on. If authorization is not received, horse will be required to renominate from beginning.
- Check in: All Futurity horses must be checked in. You will be required to bring current health papers dated within 30 days, neg. coggins test dated within 1 year, and brand inspection.
- Payback is 100% of added money plus 70% of entry fee. There will be a 30% office charge retained from the entry fee. \$5,000 guaranteed added to event. Division of the purse is equal between the 1st Go, 2nd Go, and Average. All late fees and drop out fees will be retained by Z Productions.

- Futurity Checks will be issued in the name of the owner listed on animal's registration papers.
- Must be present for awards. No awards will be mailed out.
- Full dress code required to compete.
- First go draw order designates rake breaks and is reversed for 2nd go. Rake breaks will not change for the 2nd go.
- A photocopy of the front and back of registration papers of the registered horses or veterinarian's affidavit of year of birth and complete physical description of the unregistered horse must accompany nominations. Entry will be considered late if this information doesn't accompany entry form.
- Sportsmanship: Z Productions has a no-tolerance policy with respect to animal abuse of any kind at this event. Further, foul language, misconduct or abusive comments spoken to any contestant, spectator, staff member or volunteer will result in immediate contestant disqualification and no refund of any fees. Contestants are also responsible for traveling companions and family members.
- Dogs: Must be on a leash at all times. Please clean-up after them. They are not allowed in the Indoor Arena.
- Z Productions is not responsible for personal injury, loss, theft or damage. Contestants and all accompanying parties participate at their own risk.
- Any questions or disputes during the Roper Rally Futurity not covered in the rules will be determined by Z Productions. All decisions will be final. Z Productions reserves the right to refuse entry to any horse or individual.
- All parties involved in events produced by Z Productions are responsible for reading these conditions and fully understanding their contents. Z Productions assumes no liability to those who have not read the conditions and having not read these conditions they are still held to their contents.
